

#### Property Taxes – 2015-2023










#### Water Bill (Winter Seasonal Rates)




North Fort Bend Water Authority: Surface Water Fees







## 2024 Capital Improvements Underway




- Cobble Spring Ct. Road & Storm Sewer Repairs: \$73,000

- Clover Lodge Court Waterline Replacement: \$317,000








# Vacant Land/Blossomwood Lane Update MUD4

#### Blossomwood Lane After





- Vehicle and Equipment Oil Leaks
- Chemicals
- Oils, Paints, Solvents
- Pet Waste
- Trash and Debris
- Chlorinated or Saltwater Swimming Pool Water
- Excess Lawn Clippings grass, leaves, mulch, branches
- Recyclables and Floatables
- Excess Fertilizers and Pesticides
- Construction Materials, Sediment, Silt



- Monitor rainfall and stream elevations near in near real-time
- Includes the estimated flood level of flooding in Red Gully
- Can sign up for alerts
- Gauge for Red Gully at West Airport (Gauge 8003)
